Dear Congressman Connolly:

The Federal-Postal Coalition - comprised of 31 national organizations that collectively represent five million federal and postal workers and retirees - welcomes introduction of your legislation that would extend a meaningful 3.8 percent pay raise to federal employees for calendar year 2016. Our groups strongly support this bill, and commit to seek its enactment in this new Congress.

As our nation's economy continues to recover, employers across the country are responding to tightening labor markets by increasing workers' wages and salaries. Recent Department of Labor data reflects an uptick in the size of private-sector pay raises, and given the recent three-year pay freeze for federal workers, followed by two years of one percent across-the-board pay adjustments, Congress should ensure that federal workers are not left further behind the rest of the nation's workforce. With the 2015 one percent across-the-board pay increase taking effect this month, increases in federal wages now lag private-sector raises by 6.3 percent over the last five years.

Like other employers, federal agencies must be in a position to offer competitive salaries and wages for both recruitment and retention purposes. Federal workers are presently engaged in thwarting the Ebola outbreak, leading discovery projects on Mars, and ensuring that the nation's borders remain protected. Your bill ensures that the public's needs will be met by maintaining a skilled workforce.

The Coalition thanks you for your continued strong leadership on federal employee issues, and for your efforts to safeguard the nation's civil service.
